AN ORDINANCE TO ADOPT A NEW "CITY OF ROCK HILL WARD  
SYSTEM MAP" BASED UPON THE 2010 DECENNIAL CENSUS

BE IT ORDAINED by the Governing Body of the City of Rock Hill,  
in Council assembled:

SECTION 1. That pursuant to Section 5-15-20, Section 5-15-50,  
Section 5-7-30 and Section 5-7-260 of the South Carolina Code of Laws  
for 1976, as amended, and Section 14-10, Section 2-48 and Section  
2-96 of the Code of the City of Rock Hill; and responsive to the 2010  
Decennial Census and Public Hearings held on May 4, 2011 and June 13,  
2011, the Council of the City of Rock Hill hereby adopts a new Ward  
Map of the City of Rock Hill identified as "City of Rock Hill, South  
Carolina Ward System Map," bearing date \_\_\_\_\_, as the official  
map of the City of Rock Hill, such map being incorporated herein and  
made a part hereof by reference and which is duly on file with the  
Municipal Clerk and available for public inspection.

SECTION 2. That this Ordinance and map designation become binding  
and effective for the next general election of the City of Rock Hill,  
which will take place on October 18, 2011, in which three Council  
terms of Office commencing January 9, 2012 shall be filled, such  
districts being designated as Wards numbered One, Two and Three.  
Districts being designated as Wards Four, Five and Six, as well as  
the at-large mayoral election, shall have their next general election  
take place on October 15, 2013, for four year terms commencing

January 13, 2014, so that Council terms of office shall continue the present two-year alternating cycle.

SECTION 3. That pursuant to Sections 5-15-20 and 5-15-50 of the S.C. Code, the Map adopted herein shall remain effective and binding until again revised by this body as a result of population shifts or other proper reasons.

SECTION 4. That all ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 5. That this Ordinance shall be and become finally binding immediately after same shall have received first and final readings given in the manner required by law.
