**CERTIFICATION OF UNOPPOSED CANDIDATES
CITY OF ROCK HILL
YORK COUNTY, SOUTH CAROLINA**

Whereas, the following statements are true and accurate:

- 1) Pursuant to the Code of Ordinances of the City of Rock Hill (City Code), a general election shall be held for the purpose of electing the positions of mayor and/or council members on the third Tuesday in October in each odd year.
- 2) As required by City Code, a general election was scheduled on Tuesday, October 20, 2009 for the purpose of electing the positions of Mayor and Council Member from Ward 4, Ward 5, and Ward 6.
- 3) Meeting the requirements and qualifications pursuant to the South Carolina Code of Laws and the Code of Ordinances of the City of Rock Hill, the following candidates properly filed for the positions of Mayor and Council Member as denoted below:

John Black	Council Member	Ward 4
Osbey Roddey	Council Member	Ward 5

- 4) Only one person filed for the offices of Mayor and Council Member for Ward 5.
- 5) No declarations for write-in candidates were filed for the above positions within (14) fourteen days post filing.
- 6) Tom Roper filed for the position of Council Member for Ward 4 and subsequently withdrew resulting in an uncontested election within Ward 4.
- 7) The York County Registration and Elections Commission convened on Wednesday, October 7, 2009 and ruled to cease and cancel the uncontested election within Ward 4.

Therefore, pursuant to South Carolina Code of Laws, Section 7-13-190, the York County Registration and Elections Commission hereby declares and certifies the following candidates as winners in their respective offices for the City of Rock Hill, South Carolina.
